## **Current LIHTC Pricing**

 Fund listings have been updated with information current as of December 2024, but pricing information is unchanged in this issue. On an equity-weighted basis and taking into consideration tiered pricing, participants in our latest survey, as of December 2024 – January 2025, reported a 6.61%\* equity weighted average IRR among the national multi-investor funds currently offered.

\*When an IRR range is indicated in the survey response, in lieu of complete data to calculate a weighted average fund IRR, we instead utilize the average of the IRRs reported for each fund.
